When BRATS and TRAIN collide

Who or what is BRATS?

Bringing Realtime Around the State, or BRATS, was formed in early-2010 in Ohio as an attempt to offer assistance to any county official who wanted to get together to discuss realtime in their courtrooms.

BRATS soon morphed into small-group realtime and technology sessions across the state for all reporters and captioners, not just officials.

What is TRAIN?

In early-2012, the NCRA Board, using Ohio's BRATS platform and initiative, developed TRAIN, Taking Realtime Awareness & Innovation Nationwide, which program was designed to develop and implement a plan to increase the number of court reporters capable of providing quality realtime to consumers of court reporting services.

What was TRAIN's purpose?

- Hands-on personal training
 - One-on-one
 - Small group
 - Familiar and comfortable location
- Provide resources for each realtime choice/situation a reporter may face:
 - What CAT software is being used?
 - What steno machine?
 - Which connection type?

- Improve by practice write at least 15 minutes a day
- Analyze your writing and keep a journal
- Build your dictionary
- Keep current with technology
- Offer realtime to a client you are comfortable with
- Let your software work for you
- Relax and breathe
- Stay positive
- Striving for perfection is a great goal

Samples of Tips and Tricks to make our lives so much better!

If an individual is speaking too quickly, and you have asked them to slow down, but yet, they do not and you are dropping, have a dictionary entry defined as "CHECK/CHECK" or "DROP/DROP" and define it to have the following message displayed to the realtime receiver:

(Error 629: Rapid entry exceeded. Text dropped to comment line. Reinsert upon edit.)

- Plugged in
- Correct port
- Correct COM
- Correct dongle
- Correct baud rate
- Correct CAT system

PREP TIPS

 Hook up prior to the job. Know your computer settings and check your connections

 Know your software and keep current with updates

Know full caption/style of case

SAVE TIME

- List all attorneys, participants, proper names, witnesses, case-specific terminology, technical words, and previously marked exhibits and/or exhibits to be used
- Create and enter brief forms into a job dictionary
- Practice newly created briefs before job
- Create a cheat sheet for unusual briefs as a reminder

ON THE JOB

- Control the success of your realtime feed and bring viewing devices for attorneys
- Define any untranslates during breaks
- Analyze phrases that come up frequently and create brief forms on site
- Verify spellings with witnesses and others during breaks for inclusion in job dictionary






