Beyond the Bite: How Therapy K9s Are Transforming Trauma Response*(Ref. Article III, Sects. 3.02, 3.10, and 3.11 of the CE Program Rules)*

Therapy canines are becoming an increasingly common presence in courtrooms and legal proceedings, particularly during sensitive, high-stress matters involving trauma victims, vulnerable witnesses, and emotionally charged testimony. Their presence directly affects courtroom dynamics and procedure, making it essential for court reporters and captioners to understand their role and impact within legal environments. This seminar examines the Franklin County Sheriff's Office Therapy K9 Program - established in 2017 as the first of its kind in Ohio - through its influence on courtroom operations and trauma-informed practices. Led by Sergeant Darrah Metz, the session focuses on how therapy canines are utilized in courtrooms, crisis situations, and other justice-system settings, and how proceedings may be adapted when a therapy canine is present. Attendees will gain insight into trauma-informed approaches that support professionalism, situational awareness, and stress management for court reporters and captioners routinely exposed to emotionally demanding proceedings. The program also addresses safety and deescalation considerations relevant to courtrooms, correctional facilities, and on-site legal assignments. The session does not address animal training, handling, or care, and no canines will be present, but instead centers on the procedural, professional, and safety implications of therapy canine programs within the justice system.

Sergeant Darrah Metz

Sergeant Metz is a Franklin County Sheriff's Deputy and a nationally recognized leader in the development of law enforcement therapy K9 programs. In 2017, she launched the Franklin County Sheriff's Office Therapy K9 Program, making it the first such program in Ohio and the sixth in the United States. Sergeant Metz holds a bachelor's degree in public relations and a master's degree in Interpersonal Leadership and Team Building. She has served the Franklin County Sheriff's Office in the Corrections Division, Patrol Bureau, and Community Response Bureau, and frequently speaks to schools, professional groups, and dog-trainer programs about therapy dogs, trauma response, and innovative approaches to community-centered policing.

Real Criminal Minds and CSI
(Ref. Article III, Sects. 3.02, 3.05, and 3.10 of the CE Program Rules)

Television crime dramas make investigations look fast, flashy, and simple, but real cases are built through analysis, collaboration, and attention to detail. In this fascinating session, retired Lieutenant Al Sternberg takes attendees behind the scenes of real criminal investigations to show how complex cases are actually identified, developed, and solved. Using real-world examples from homicide, fraud, identity theft, and cybercrime investigations, Lt. Al will explore how investigators analyze "micro" and "macro" financial transactions, build cases through criminal infrastructure patterns, and rely on partnerships with specialists. He also examines the craft of interviewing beyond the classic good cop/bad cop approach, the strategic use of evidence, and the often-overlooked realities of evidence room management. This session offers a rare look at how strong analytical skills and disciplined thinking power real criminal investigations, and the people and records that document them.

Real Criminal Minds and CSI

Al Sternberg

Lieutenant (retired) Wake County Sheriff's Office

Evidence Custodian and Investigator

Lieutenant Al (Ret.) served nearly 30 years with the Wake County Sheriff's Office in North Carolina, building a distinguished career spanning patrol, crime prevention, public relations, complex investigations, and evidence management. Beginning his service in 1988, Lt. Al developed specialized expertise in computer crimes, fraud, homicide, and major investigations, ultimately rising to the rank of Lieutenant and serving as Evidence Custodian until his retirement in 2018. His investigative work included participation in more than 1,800 cases, including high-profile homicide, large-scale financial fraud, and identity theft investigations, several of which are now referenced in training materials and academic publications. His service has been recognized with multiple awards, including the Wake County Sheriff's Office "Mr. Z" Deputy of the Year Award and a special award of thanks for work on the Xavier Jennette identity theft case.

Since 2017, Lt. Al has brought his investigative and evidentiary expertise to the court reporting profession as a self-employed Eclipse scopist and North Carolina Judicial Transcriptionist, certified by the North Carolina Administrative Office of the Courts. He specializes in complex and non-traditional recordings, including police interviews, body-worn and dash-camera footage, jail phone calls, and other challenging audio sources. He also serves as a lead team scopist and document manager for an international arbitration daily copy team. Lt. Al's unique combination of law enforcement, evidence handling, and transcription experience offers valuable insight into accuracy, context, and integrity in the creation of the official record.
